Report to accompany S. 2042, to reauthorize the Interagency Committee on Women’s Business Enterprise. (S. Rept. No. 117–104)

#### Measures Passed:

**Vaccine and Mask Requirements:** By 55 yeas to 41 nays (Vote No. 147), Senate passed S.J. Res. 39, providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of Health and Human Services relating to “Vaccine and Mask Requirements To Mitigate the Spread of COVID–19 in Head Start Programs”. **Pages S2259–66**

**Safe Sleep for Babies Act:** Committee on Commerce, Science, and Transportation was discharged from further consideration of H.R. 3182, to provide that inclined sleepers for infants and crib bumpers shall be considered banned hazardous products under section 8 of the Consumer Product Safety Act, and the bill was then passed. **Page S2291**

**Multinational Species Conservation Funds Semipostal Stamp:** Senate passed H.R. 6023, to require the United States Postal Service to continue selling the Multinational Species Conservation Funds Semipostal Stamp until all remaining stamps are sold. **Page S2291**

**National Specialized Instructional Support Personnel Appreciation Week:** Committee on Health, Education, Labor, and Pensions was discharged from further consideration of S. Res. 604, supporting the designation of the week of April 25 through April 29, 2022, as “National Specialized Instructional Support Personnel Appreciation Week”, and the resolution was then agreed to. **Page S2291**

**National Minority Health Month:** Senate agreed to S. Res. 613, promoting minority health awareness and supporting the goals and ideals of National Minority Health Month in April 2022, which include bringing attention to the health disparities faced by minority populations of the United States such as American Indians, Alaska Natives, Asian Americans, African Americans, Hispanics, and Native Hawaiians or other Pacific Islanders. **Pages S2291–92**

**Gioblastoma Awareness Day:** Senate agreed to S. Res. 614, designating July 20, 2022, as “Gioblastoma Awareness Day”. **Page S2292**

S. 1222, to designate and adjust certain lands in the State of Utah as components of the National Wilderness Preservation System;

S. 1321, to modify the boundary of the Casa Grande Ruins National Monument, with an amendment;

S. 1631, to authorize the Secretary of Agriculture to convey certain National Forest System land in the State of Arizona to the Arizona Board of Regents, with amendments;

S. 1942, to standardize the designation of National Heritage Areas, with an amendment in the nature of a substitute;

S. 2438, to modify the boundary of the Cane River Creole National Historical Park in the State of Louisiana, with an amendment; and

S. 3266, to improve recreation opportunities on, and facilitate greater access to, Federal public land, with an amendment in the nature of a substitute.
