**Disclosing Foreign Influence in Lobbying Act:** Senate passed S. 4254, to amend the Lobbying Disclosure Act of 1995 to clarify a provision relating to certain contents of registrations under that Act. **Pages S6049–50**

**Speak Out Act:** Senate passed S. 4524, to limit the judicial enforceability of predispute nondisclosure and nondisparagement contract clauses relating to disputes involving sexual assault and sexual harassment, after agreeing to the committee amendment in the nature of a substitute. **Page S6050**

**STURDY Act:** Senate passed S. 3232, to require the Consumer Product Safety Commission to promulgate a consumer product safety rule for free-standing clothing storage units to protect children from tip-over related death or injury, after agreeing to the committee amendment in the nature of a substitute. **Pages S6050–51**

**CHIP-IN Improvement Act:** Senate passed S. 5059, to improve the pilot program on acceptance by the Department of Veterans Affairs of donated facilities and related improvements to account for issues relating to inflation. **Pages S6051–52**

**FTC Collaboration Act:** Committee on Commerce, Science, and Transportation was discharged from further consideration of H.R. 1766, to enhance cooperation between the Federal Trade Commission and State Attorneys General to combat unfair and deceptive practices, and the bill was then passed. **Page S6052**
