## Senate

### Chamber Action

*Routine Proceedings, pages S1275–S1317*

**Measures Introduced:** Thirty-five bills and five resolutions were introduced, as follows: S. 1221–1255, and S. Res. 165–169. **Pages S1293–94**

#### Measures Passed:

**Fire Grants and Safety Act:** By 95 yeas to 2 nays (Vote No. 94), Senate passed S. 870, to amend the Federal Fire Prevention and Control Act of 1974 to authorize appropriations for the United States Fire Administration and firefighter assistance grant programs, by the order of the Senate of Tuesday, April 18, 2023, 60 Senators having voted in the affirmative, and after taking action on the following amendments proposed thereto: **Pages S1277–85, S1285**

#### Rejected:

By 46 yeas to 51 nays (Vote No. 92), Van Hollen/Murkowski Amendment No. 85, to provide grants for fire station construction through the Administrator of the Federal Emergency Management Agency. (Pursuant to the order of Tuesday, April 18, 2023, the amendment having failed to achieve 60 affirmative votes, was not agreed to.) **Pages S1278–80**

By 42 yeas to 56 nays (Vote No. 93), Sullivan Amendment No. 83, relating to eligible use for grant funds. **Pages S1280–81**

#### Withdrawn:

Schumer Amendment No. 58, to add an effective date. **Pages S1277, S1281**

**United States Holocaust Memorial Museum 30th Anniversary:** Senate agreed to S. Res. 167, recognizing the 30th anniversary of the United States Holocaust Memorial Museum. **Pages S1286–89**

#### Measures Considered:

**VA Medicinal Cannabis Research Act—Cloture:** Senate began consideration of the motion to proceed to consideration of S. 326, to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health

outcomes of veterans with chronic pain and post-traumatic stress disorder. **Pages S1285–86**

A motion was entered to close further debate on the motion to proceed to consideration of the bill, and, in accordance with the provisions of Rule XXII of the Standing Rules of the Senate, a vote on cloture will occur upon disposition of the nomination of Joshua David Jacobs, of Washington, to be Under Secretary for Benefits of the Department of Veterans Affairs. **Page S1286**

Aquilino, USN, Commander, United States Indo-Pacific Command, and General Paul J. LaCamera, USA, Commander, United Nations Command, Commander, United States-Republic of Korea Combined Forces Command, and Commander, United States Forces Korea, both of the Department of Defense.

**Public Bills and Resolutions Introduced:** 61 public bills, H.R. 2733–2793; and 7 resolutions, H. Res. 310–316, were introduced. **Pages H1906–09**

*Protection of Women and Girls in Sports Act of 2023:* The House passed H.R. 734, to amend the Education Amendments of 1972 to provide that for purposes of determining compliance with title IX of such Act in athletics, sex shall be recognized based solely on a person's reproductive biology and genetics at birth, by a yea-and-nay vote of 219 yeas to 203 nays, Roll No. 192. Consideration began yesterday, April 19th. **Pages H1890–93, H1893–96**

Rejected the Balint motion to recommit the bill to the Committee on Education and the Workforce by a yea-and-nay vote of 204 yeas to 218 nays, Roll No. 191. **Pages H1894–95**

Agreed to:

Ogles amendment (No. 2 printed in H. Rept. 118–37) that clarifies that the term “athletic programs and activities” includes any activities a recipient chooses to restrict only to members of a team; and **Pages H1892–93**

Mace amendment (No. 1 printed in H. Rept. 118–37) that requires the Comptroller General shall carry out a study to determine the meaning of the phrase ‘any other benefit’ as used in subsection (d)(3) by looking at the adverse psychological, developmental, participatory, and sociological results to girls of allowing males to compete, be members of a sports team, or participants in athletic programs, that are designed for girls, including hostile environ-

ment creation, sexual assault, and sexual harassment (by a recorded vote of 216 yeas to 205 noes, Roll No. 190). **Pages H1893–94**

H. Res. 298, providing for consideration of the bill (H.R. 734) and the joint resolution (H.J. Res. 42) was agreed to Tuesday, April 18th.

**Meeting Hour:** Agreed by unanimous consent that when the House adjourns today, it adjourn to meet at 11 a.m. on Monday, April 24th. **Page H1896**

**Quorum Calls—Votes:** Two yea-and-nay votes and one recorded vote developed during the proceedings of today and appear on pages H1893–94, H1894–95, and H1895–96.

**Adjournment:** The House met at 9 a.m. and adjourned at 12:46 p.m.

*Committee on Foreign Affairs:* Subcommittee on Global Health, Global Human Rights, and International Organizations held a hearing entitled “China’s Political Prisoners: Where’s Gao Zhisheng?”. Testimony was heard from public witnesses.

#### MISCELLANEOUS MEASURES

*Committee on the Judiciary:* Full Committee concluded a markup on H.R. 2640, the “Border Security Enforcement Act of 2023”; and H.J. Res. 44, providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Bureau of Alcohol, Tobacco, Firearms, and Explosives relating to “Factoring Criteria for Firearms

with Attached ‘Stabilizing Braces’”. H.R. 2640 was ordered reported, as amended. H.J. Res 44 was ordered reported, without amendment.
