Waters Act", H. Res. 1112, Denouncing the Biden administration's immigration policies, and H. Res. 1117, Opposing efforts to place one-sided pressure on Israel with respect to Gaza. The rule provides for consideration of H.R. 7888, the "Reforming Intelligence and Securing America Act", under a structured rule. The rule waives all points of order against consideration of the bill. The rule provides two hours of general debate equally divided among and controlled by the chair and ranking minority member of the Committee on the Judiciary or their respective designees and the chair and ranking minority member of the Permanent Select Committee on Intelligence or their respective designees. The rule provides that the bill shall be considered as read. The rule waives all points of order against provisions in the bill. The rule makes in order only those amendments printed in the report. Each amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question. The rule waives all points of order against the amendments printed in the report. The rule provides for one motion to recommit. The rule further provides for consideration of H.R. 529, the "Extending Limits of U.S. Customs Waters Act", under a closed rule. The rule waives all points of order against consideration of the bill. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Ways and Means now printed in the bill shall be considered as adopted and the bill, as amended, shall be considered as read. The rule waives all points of order against provisions in the bill, as amended. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Ways and Means or their respective designees. The rule provides for one motion to recommit. The rule further provides for consideration of H. Res. 1112, Denouncing the Biden administration's immigration policies, under a closed rule. The rule provides that upon adoption of this resolution it shall be in order without intervention of any point of order to consider H. Res. 1112. The rule provides that the resolution shall be considered as read. The rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on the Judiciary or their respective designees. The rule further provides for consideration of H. Res. 1117, Opposing efforts to place one-sided pressure on Israel with respect to Gaza, under a

closed rule. The rule provides that upon adoption of this resolution it shall be in order without intervention of any point of order to consider H. Res. 1117. The rule provides that the resolution shall be considered as read. Finally, the rule provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Foreign Affairs or their respective designees.
