H.R. 8290, to amend the Internal Revenue Code of 1986 to require the public disclosure of grants made by certain tax-exempt organizations to foreign entities, with an amendment (H. Rept. 118–569); and

H.R. 8292, to amend the Internal Revenue Code of 1986 to increase penalties for unauthorized disclosure of taxpayer information, with an amendment (H. Rept. 118–570). **Page H4442**

**Department of Defense Appropriations Act, 2025:** The House passed H.R. 8774, making appropriations for the Department of Defense for the fiscal year ending September 30, 2025, by a yea-and-nay vote of 217 yeas to 198 nays, Roll No. 331. Consideration began Thursday, June 27th. **Pages H4415–23**

Rejected the Quigley motion to recommit the bill to the Committee on Appropriations by a yea-and-nay vote of 202 yeas to 211 nays, Roll No. 330.

Consideration began Wednesday, June 26th.

**Department of State, Foreign Operations, and Related Programs Appropriations Act, 2025:** The

House passed H.R. 8752, making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2025, by a ye-and-nay vote of 212 yeas to 200 nays, Roll No. 335. Consideration began Wednesday, June 26th. **Pages H4424–26**

Rejected the Meng motion to recommit the bill to the Committee on Appropriations by a ye-and-nay vote of 200 yeas to 212 nays, Roll No. 334.
